- Work closely with contracting and requirements personnel to make sure small business has maximum opportunity to participate in all NUWCDIVNPT procurements
- Review all NUWCDIVNPT procurements exceeding \$10K
- Promulgation of Long Range Acquisition Forecast



- If you see something in a solicitation that looks overly restrictive, say something
 If you have questions, ask!
 - Ask for a debrief
